



Cookies policy

The present **Cookies Policy** forms an inseparable part of the **myPOS Privacy Policy**, which you should read in order to obtain a fuller understanding of our data processing activities and also your rights under the applicable legislation.

The Data Controller for this type of processing of personal data is **myPOS Limited - Bulgaria Branch, Company Number 207893022, having its seat and registered address in Varna, 9023, Mladost District, Business Park Varna B6** (hereinafter referred to as “**we**”, “**us**” or other similar).

We use “**Cookies**” and other tracking technologies (hereinafter referred to collectively as “**Cookies**”) when you visit or use our websites or mobile apps. In this document you may find more information and details on about the **Cookies** and the similar technologies as well as to understand how to control them.

Definitions:

For the purposes of the present Policy, the following terms shall have the meaning shown hereinbelow:

“**myPOS Website**” shall mean any website, which provides access to the **myPOS Platform**.

“**Mobile App**” shall mean the official application, available for Android and iOS, which provide access to the **myPOS Platform**.

“**myPOS Platform**” shall mean a FinTech platform providing acceptance of card-present and card-not-present payments in various currencies with instant settlement in a single or multiple e-money account/s designated with IBANs and instant access to cash via myPOS Card and credit transfers and direct debits, as well as other payment services, provided by licensed Electronic Money Institutions.

Types of Cookies used on the myPOS Website and Mobile App.

1. Necessary Cookies

Necessary Cookies are used by us to ensure the proper operation of our website, including by helping us create a secure environment for the **myPOS Platform**. We would not be able to provide you with access to our services without these **Cookies** and therefore you cannot refuse them. You can use your browser’s settings in order to delete and/or remove them later.

If you have configured your computer to automatically display images or if you have configured your computer to have "weak" security, **Necessary Cookies** might be set at the same time as you download, open or read the **myPOS Website** and **Mobile app**. If you would prefer for this not to happen, you should disable the automatic displaying of images or strengthen your security settings.

These **Cookies** are based on our legitimate interests and therefore you do not need to consent for us to store these **Cookies**.

A short description of the purpose and storage duration of these **Cookies** is included in the list provided hereto.

2. Personalization Cookies

We use these **Cookies** to improve our user’s myPOS experience, including by making our offers and ads more relevant to your interests.

These **Cookies** are based on your revocable consent. Therefore, we shall not store or use these **Cookies** without your explicit action to confirm the storage/use of these **Cookies**.

You may revoke the consent you have given at any time, free of charge, by using our website’s Cookie panel or by deleting them as explained in the next section.

How to control and delete Cookies through your browser.

The ability to disable or delete **Cookies** can also be carried out by changing your browser’s settings. In order to do this, follow





the instructions provided by your browser (usually found in the ‘Help’, ‘Edit’ or ‘Tools’ facility). Some pages may not work if you completely disable all **Cookies**, but many third-party **Cookies** can be safely blocked.
